- Use drugs, except for legal medical purposes, or be in the presence of any WSU student while he/she uses drugs for illegal purposes
- Consume alcohol, or be in the presence of any WSU student while he/she consumes alcohol.
- Engage in any relationship with a WSU student outside the bounds of student and coach
- Engage in any activity that is considered a crime in the state of Michigan
- Strike, attempt to strike, or otherwise physically or verbally abuse an official, opposing player, teammate, spectator or coach.
- Intentionally engage in or incite participants and/or spectators to engage in abusive or violent action.
- Use obscene gestures, profanity, or disrespectful language.
- Violate any host university, hotel, city, or state rules or policies.

## I agree that I have:

- Thoroughly read and understood this document prior to signing.
- Thoroughly read and understood the Club Sports Handbook and all policies regarding student development and coaching standards/guidelines.
- Agreed to abide by all WSU Policies
- Agreed to all WSU employment procedures and regulations pursuant with this voluntary position.
- Agreed to submit to a full criminal background check
- Properly registered with the team's governing body and acquired the proper insurance coverage
- Paid all club dues and fees on designated dates.

- Fines or fees that may result from any violations.
- Disciplinary action as deemed appropriate by Wayne State University and the Board of Club Sports.
- Criminal prosecution
